Review Engagement Report

To the Members of

At the request of Sachigo Lake First Nation, we have reviewed the Schedule of Remuneration and Expenses - Chief and Councillors for the year ended March 31, 2015, calculated pursuant to the requirements of the Aboriginal Affairs and Northern Development Canada Year End Reporting Handbook. Our review was made in accordance with Canadian generally accepted standards for review engagements and accordingly consisted primarily of inquiry, analytical procedures and discussion related to information supplied to us by the organization.

A review does not constitute an audit and, consequently, we do not express an audit opinion on the Schedule of Remuneration and Expenses - Chief and Councillors for the year ended March 31, 2015. The Schedule is prepared to assist the organization to meet the disclosure requirements of Aboriginal Affairs and Northern Development Canada Year End Reporting Handbook and the First Nations Financial Transparency Act (FNFTA). As a result, the schedule may not be suitable for another purpose. Our report is prepared solely for Sachigo Lake First Nation and Aboriginal Affairs and Northern Development Canada and should not be used by other parties.

Based on our review, nothing has come to our attention that causes us to believe that the Schedule of Remuneration and Expenses - Chief and Councillors is not, in all material respects, in accordance with the Aboriginal Affairs and Northern Development Canada Year End Reporting Handbook and the First Nations Financial Transparency Act (FNFTA).
